**MINUTES OF THE MEETING OF THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT
TO DETERMINE SUITABILITY OF NURSING COLLEGES IN M.P.
HELD ON 25 and 26th May 2025 at BHOPAL**

25th May 2025

Member Sh. RS Julaniya and Member Sh. Tripathi present in person. Chairman Jst. Sh. Shrivastava joined online.

2. Pursuant to the meeting dated 15th May 2025 notes were exchanged between the Chairman and Committee Members. Member Mr. Julaniya put together the findings and recommendations in the form of Draft Report. The Committee considered and arrived at consensus on the salient recommendations. However, it was felt that since the recommendations include the subject of paramedical sciences (allied sciences), it would be in the fitness of things to hear the Registrar/Chairman of the Paramedical Council. Today being Sunday, a public holiday, and there being no notice to the Registrar of the Paramedical Council, the Committee decided to meet again. Accordingly, the meeting was scheduled for tomorrow ie 26th May 2025.

3. Member Sh. RS Julaniya and Member Sh. Tripathi present in person. Chairman Jst. Sh. Shrivastava joined online. The Nodal Officer Dr. CP Shukla assisted the Committee.

4. The Committee interacted with Dr. Sheloj Joshi, Registrar of the MP Paramedical Council and deliberated upon the finer nuances of allied health sciences education. The Draft Report was modified appropriately to address the exigencies of allied health sciences education. The Committee finalised its final report and recommendations for submission to the Hon'ble High Court.

5. This meeting being the last meeting of the Committee, the Committee strongly feels it appropriate to record its appreciation of the services rendered by Nodal officer Dr. CP Shukla. But for his positive attitude, fairness in approach and attitude to assist against all odds, the Committee would have not been able to fulfil the mandate given by the Hon'ble High Court. Dr. Shukla earned the wrath of not only his seniors and colleagues in the MPNRC but of the vested interests who could not succeed in misleading the Committee. On one occasion his services were withdrawn from the Committee and required intervention of the Hon'ble Court. Very often when recommendations of the Committee did not suit a College, Dr. Shukla was a natural punching bag. There were occasions when actions of the Committee were falsely attributed to Dr. Shukla's manoeuvring. This is a fact of life that a good officer often ends up earning the wrath of vested interests for no fault of his. However, such officers stand protected by the Hon'ble Court, and the Committee hopes so.

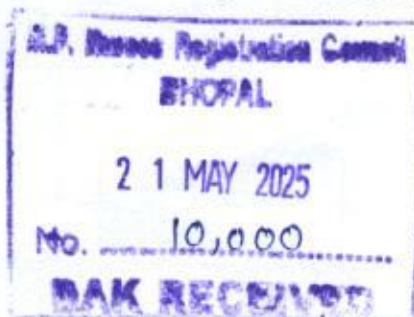



TO DETERMINE SUITABILITY OF NURSING COLLEGES IN M.P.
HELD ON 15th May 2025 at BHOPAL**


Chairman Jst. Sh. Shrivastava, Member Sh. RS Julaniya and Member Sh. Tripathi present in person. The Nodal Officer Dr. CP Shukla presented cases of the Colleges.


2. Cases of 11 colleges for determination of removal of deficiencies or otherwise are pending with the Committee. Status with regard to these colleges is as below:


#	Nursing College	Findings	Ground
1	Adarsh Institute of Nursing, Nainpur, Mandla	Suitable.	The Committee got the College inspected by writing to the District Collector, Mandla. The letter dated 24.04.2025 of the Collector and accompanying documents show that the College has removed the deficiencies.
2	School of Nursing, Christian Hospital, Chhatarpur	Deficient as on 04.03.2025	These College requested for time to remove deficiencies. In view of the order dated 25 April 2025 of the Hon'ble High Court in WP No. 14179 of 2025 wherein the Hon'ble Court has noted that the purpose of forming the special committee is over and that no College(s) or student is required to appear before the Committee. Therefore, the Committee did not consider it appropriate to call these colleges and hear them.
3	Narayan College of Nursing, Gwalior	Deficient as on 12.02.2025	
4	Vishal Vate Memorial College of Nursing, Bhopal	Deficient as on 11.02.2025	
5	MM School of Nursing, Jabalpur	Deficient as on 11.02.2025	
6	Sukh Sagar College of Nursing, Jabalpur	Deficient as on 03.04.2025	
7	Arogya Nursing College, Gwalior	Deficient as on 11.02.2025	The Committee felt the need to visit these Colleges to determine removal of deficiencies or otherwise by them, as the records did not satisfy the Committee. However, in view of the order dated 25 April 2025 of the Hon'ble High Court in WP No. 14179 of 2025 wherein the Hon'ble Court has noted that the purpose of forming the special committee is over and that no College(s) or student is required to appear before the Committee. Therefore, the Committee did not consider it appropriate to inspect these Colleges and take a view on removal of deficiencies or otherwise.
8	BR Nursing College, Morena	Deficient as on 04.03.2025	
9	Shri Maharaj Singh College of Nursing, Gwalior	Deficient as on 04.03.2025	
10	Shri Krishna College, Mungawli	Deficient as on 04.03.2025	
11	Grantham School of Nursing, Gwalior	Deficient as on 12.02.2025	

3. The Nodal Officer is advised to handover all records of the above Colleges to MPNRC to consider their cases in view of the prevailing norms after site inspections.

4. The Committee deliberated upon the mandate given by the Hon'ble Court and mandate wise compliance thereof. On the issue of recommendations to be made to the Hon'ble Court, it was decided to exchange notes between the Chairman and Members so as to finalise the report of the Committee in its next and final meeting.
