MINUTES OF THE MEETING OF THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT TO DETERMINE SUITABILITY OF NUSRING COLLEGES IN M.P. HELD AT GANDHI MEDICAL COLLEGE, BHOPAL ON 21st JANUARY 2025

Member Sh. RS Julaniya joined in person while Chairman Sh. RK Shrivastava and Member Sh. Shreeprakash Mani Tripathi joined online. Nodal Officer Dr. CP Shukla assisted the Committee.

The Committee considered representations of the following colleges in its meetings from 12th to 15th January and made its recommendations based on the documents:

- 1. Veerangna Awantibai Nursing College, Chhatarpur
- 2. Gyanveer Sursing College, Sagar
- 3. BM School of Nursing, Vidisha
- 4. Shree Ramraja College of Nursing, Niwari

The above colleges made representations to the Committee that their cases were considered without affording them opportunity of personal hearing. The Committee had considered their cases based on documents only for paucity of time as the Hon'ble High Court expected that the Committee would determine their suitability or otherwise by 15th January 2025.

Since the Committee arrived at a definite finding with regard to the above colleges and submitted its report to the Hon'ble Court it is considered appropriate to await the orders of the Hon'ble Court in the matter listed on 23rd January for hearing.

5. Narmada Institute of Nursing, Badwah, Khargone

Sh. Pawan Kumar, Principal and Professor Ms Reshma Lal present.

The College submitted its representation to the Registrar, MPNRC on 20th January 2025 which was received to the Nodal Officer of the Committee on the same day. Therefore, the Committee took up the representation today.

The Hon'ble High Court in its order dated 7th January in WP No. 20 of 2025 directed petitioner nursing Colleges to appear before this Committee and satisfy it with regarding to removal of deficiencies observed by the CBI team in second round of inspections carried out in compliance to the orders of the Hon'ble Court.

Perusal of the orders shows that the Petitioner nursing colleges have obtained order of the Hon'ble Court by misrepresentation and making factually incorrect submissions. They led to the Hon'ble Court to believe that the extant Committee has been constituted for examining the representations of colleges found deficient by the CBI team in the second round of inspections. The petitioner pleaded before the Hon'ble Court that in WP No. 1080/2022 order dated 13.02.2024 the Hon'ble Court had formulated this Committee to satisfy about the removal of the deficiencies pointed out by the CBI in the second round of inspection.

The fact is that this Committee has been formed by the Hon'ble Court with regard to the Colleges found deficient in the initial (first round of CBI inspections. In addition, the Hon'ble





Court in individual cases has directed some Colleges who were found unsuitable in CBI inspections or found deficient in second round of inspections.

The Hon'ble Court in WP No. 38524 of 2024 specifically expressed in para 4 of the Order that ".....instead of directing the Committee, the deficiencies as have been pointed-out by the CBI in second round of inspection, can be considered by the Respondent No. 4". Respondent No. 4 in this WP was the MPNRC.

Accordingly, this Committee has been considering cases of only such Colleges who have been specifically directed by the Hon'ble Court to satisfy this Committee regarding removal of deficiencies.

Notwithstanding the fact that the Petitioner colleges have obtained the orders of the Hon'ble Court by false statement regarding the orders of the Hon'ble Court, the Committee decided to consider the case instead of referring back the matter to the Hon'ble Court.

In its inspection of the College by CBI team on 25.09.2024, it noted deficiencies of a) built-up area is 12,079 square feet which is less than norms, b) small sizes of class rooms, labs and library, c) no class room for BSc III and IV year, d) inadequate teaching faculty and e) non availability of AV Aid lab room.

Sh. Pawan Kumar represented that the deficiencies noted by CBI team have been removed in the following manner:

- a) After additional construction the built-up area is 21,000 square feet.
- b) By alterations and removal of walls in the building, area of class rooms, library and laboratories have been increased to meet the norms.
- c) Class rooms for BSc III and IV year and AIV Aid lab have been provided.
- d) Presently, the College has only 28 BSc students. It has sanction for 60 seats for GNM only. Earlier it got sanction of 30 seats for BSc but did not obtain sanction for BSc seats since 2022-23.
- e) After recruitment of additional faculty, the College has a faculty strength of one principal, one vice principal, 2 associate professors, 2 assistant professors and 20 tutors.
- f) The College has bed allocation for practical training from 140 bedded Government Civil Hospital, Badwah.

Documents and photos submitted by the College support the assertions made by Sh. Pawan Kumar. Hence, the Committee is satisfied that deficiencies noted by CBI team have been remedied. Therefore, the Committee finds and recommends that:

- For present students: the College is suitable.
- 2. For future students: Suitable subject to bed allocation from eligible 100 bedded functional hospital.



DP Chaturvedi School of Nursing, Seoni

Dr. KK Chaturvedi, Chairman of Shriram Adarsh education Society running the College and Director of the College and Sh. Sumit Sanodiya, Vice Principal of the College present.

The College submitted its representation to the Registrar, MPNRC on 8th January 2025 which was received to the Nodal Officer of the Committee on 20th January 2025. Therefore, the Committee took up the representation today.

The Hon'ble High Court in its order dated 10th January in WP No. 958 of 2025 directed petitioner nursing College to appear before this Committee and satisfy it with regarding to removal of deficiencies observed by the CBI team in second round of inspections carried out in compliance to the orders of the Hon'ble Court.

Perusal of the orders shows that the Petitioner nursing college has obtained order of the Hon'ble Court by misrepresentation and making factually incorrect submissions. They led to the Hon'ble Court to believe that the extant Committee has been constituted for examining the representations of colleges found deficient by the CBI team in the second round of inspections. The petitioner pleaded before the Hon'ble Court that in WP No. 1080/2022 order dated 13.02.2024 the Hon'ble Court had formulated this Committee to satisfy about the removal of the deficiencies pointed out by the CBI in the second round of inspection.

The fact is that this Committee has been formed by the Hon'ble Court with regard to the Colleges found deficient in the initial (first round of CBI inspections. Geo-tagged photos of the College show that in the said building of the Society it is running the DP Chaturvedi Science, Commerce, Arts and Education College on the first and second floor. Dr. Chaturvedi stated that the Science, Commerce, Arts College would be shifted to a new building by April 2024.

The College has sanction for 60 seats for GNM and presently has 120 students. It does not have any parent hospital and has bed allocation from District Hospital, Seoni.

Based on the documents and photos submitted by the College the Committee is not satisfied with regard to removal of deficiencies. Sh. Chaturvedi requested for time for removal of deficiencies.

The Committee recommends that:

- 1. The College is presently unsuitable for nursing education.
- 2. Present students be shifted to another suitable nursing colleges.
- The College may apply for recognition as and when it acquires eligibility under the rules.

7. Adarsh Institute of Nursing, Nainpur, Mandla

Sh. Anand Soni, Secretary of the Adarsh Education and Welfare Society running the College present.

The College submitted its representation dated 15th January 2025 which was received to the Nodal Officer of the Committee on 16th January 2025. Therefore, the Committee took up the representation today.

The Hon'ble High Court in its order dated 10th January in WP No. 1097 of 2025 directed the Respondents to include the College in the list of suitable colleges for participating in counselling if the Petitioner College has removed deficiencies.

Perusal of the order shows that the Petitioner nursing college has obtained order of the Hon'ble Court by making factually incorrect submission. It has led the Hon'ble Court to





believe that the extant Committee has been constituted for examining the representations of colleges found deficient by the CBI team in the second round of inspections. The petitioner contented before the Hon'ble Court that in WP No. 1080/2022 order dated 13.02.2024 the Hon'ble Court had formulated this Committee to satisfy about the removal of the deficiencies pointed out by the CBI in the second round of inspection.

The fact is that this Committee has been formed by the Hon'ble Court with regard to the Colleges found deficient in the initial (first round of CBI inspections. In addition, the Hon'ble Court in individual cases has directed some Colleges who were found unsuitable in CBI inspections or found deficient in second round of inspections.

The Hon'ble Court in WP No. 38524 of 2024 specifically expressed in para 4 of the Order that ".....instead of directing the Committee, the deficiencies as have been pointed-out by the CBI in second round of inspection, can be considered by the Respondent No. 4". Sh. Anand Soni stated that the College has sanction for 50 seats of GNM and has 95 students presently. It has a faculty of 15 comprising of a principal, a vice principal and 13 tutors. The College has bed allocation from 100 bedded Government Civil Hospital, Nainpur located at a distance of app. 2 KM.

Geo-tagged photos of the College show that the College building is G+2 story. The College questioned findings of the CBI with respect to area. Therefore, physical verification is required to verify facts before arriving at any conclusive finding.

8. Kothari Institute of Nursing, Jabalpur

Mr, Vinay Kumar Tiwari, Director of the College, Principal Ms. Amita Tiwari and Tutor Ms. Ichcha Tiwari present.

The Committee had heard the College in its meting dated 17-18 December 2024 wherein Mr. Tiwari sought time to remove deficiencies noted by CBI team.

CBI had found the college unsuitable in its inspection on the ground of deficiencies of a) inadequate area of only 6,400 square feet, b) vacancy of principal and vice principal, c) small sizes of all class rooms, d) non-availability of AV Aid room and advanced nursing labs, e) insufficient toilet facilities, f) small sizes and poorly equipped laboratories and library, etc.

The College approached the Hon'ble High Court stating that it was found suitable by CBI in its earlier inspection but found it deficient in later inspection. The Hon'ble High Court, vide its order dated 14th November 2014, directed the College to appear before the Committee and satisfy it with regard to suitability of the College.

The deficiencies noted by CBI team and representation of the College regarding remedial measures taken up by it are as below:

According to Principal Ms Amita Tiwari the College has sanction for 60 seats for BSc program and has 135 students presently. It has a faculty of 18 comprising of a principal, vice principal, 2 associate professors, 3 assistant professors and 11 tutors.

Since the College has failed to produce proof (geo-tagged photos and documents) to satisfy the Committee regarding removal of deficiencies despite getting ample time, the Committee finds that the College is not serious about its affairs. The Committee cannot help a college who is not serious in managing and running its affairs.

Therefore, the Committee recommends that:

- 1. The College is presently unsuitable for nursing education.
- 2. Present students be shifted to another suitable nursing colleges.
- The College may apply for recognition as and when it acquires eligibility under the rules.

The Committee denied this request for it cannot allow itself to be an instrumentality for perpetuation of the fraud.
