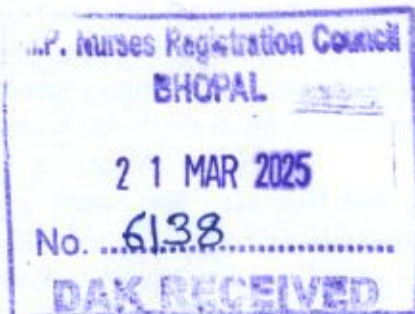

MINUTES OF THE MEETING OF THE COMMITTEE APPOINTED BY THE HON'BLE HIGH COURT TO DETERMINE SUITABILITY OF NURSING COLLEGES IN M.P. HELD AT CIRCUIT HOUSE, JABALPUR ON 17th March 2025

Chairman Jst. Sh. Srivastava and Member Sh. RS Julaniya present in person. Member Sh. Tripathi attended by video conferencing. The Nodal Officer Dr. C.P. Shukla presented cases of the Colleges.

The Committee considered cases of the following Colleges:

1. Onkar College of Nursing, Guna (OMKAR)

Chairman Sh. Pradeep Kumar Sen, Director, Dr. Madhu Krishnani, Vice Principal Sh. Nirmal Nagar and Academic Head Sh. Dharmendra Sen of the College present.

The College appeared before the Committee pursuant to the Orders dated 3rd March 2025 of the Hon'ble Supreme Court passed in Civil Appeal No. 3534-3535 of 2025. The Apex Court had directed this Committee to consider whether the College fulfils the eligibility criterion to run the nursing college.

CBI in its inspection report dated 4th July 2024 found the College 'suitable with minor deficiencies' on account of (a) minor deficiencies of area of some labs and class rooms, (b) non-availability of MoU with parent hospital and (c) not obtaining permission for clinical training from mental health hospital.

According to the College when it came to know from the information displayed on the portal of the MPNRC that its application for recognition for the academic year 2024-25 was rejected due to finding of unsuitability by the CBI, it approached the Hon'ble High Court. The Hon'ble Court directed the CBI on 14.11.2024 in WP No. 35061 of 2024 to provide copy of its report to the College. In compliance, CBI informed the College vide its letter dated 15.11.2024 that it found the College unsuitable on account of running of B.Ed. program in the same building. The College filed another Writ Petition before the Hon'ble Court. The Hon'ble Court during its hearing in WP 36783 of 2024 on 12.12.2024 got the District Magistrate (DM) to visit the College at once and do the Video recording, and thereafter, obtaining the report of the DM the Hon'ble Court noted that (a) B.ED. and nursing programs are running in the same building and (b) the total area available with the College is for these two distinct programs is 24,912.62 sq.ft. as against the required total area of 39,000 sq.ft. The Hon'ble Court dismissed the Petition. In this backdrop the College preferred an appeal before the Hon'ble Supreme Court wherein the Hon'ble Court passed the above-mentioned directions.

The Committee examined the eligibility of the College for recognition for nursing education in terms of recognition rules applicable for recognition of nursing colleges in Madhya Pradesh.

The findings of the Committee on the basis of documents, photographs and submissions made by the College are as follows:

- a. **Building:** The College has a 3+1 top floor (temporary roof with false ceiling) admeasuring 42,298 sq ft. It has arranged another building for B.Ed. program and shifted its B.Ed. education to that building. Thus, the entire building is now available for nursing education.
- b. **Room sizes:** Room sizes have been suitably modified by internal modification and relocation of class rooms and labs etc.
- c. **Faculty:** College provided a list of 48 faculty members. MPNRC records show that the faculty has requisite qualifications. The College submitted bank statement to show regular payment of salary.
- d. **Hospital:** The College has a 100 bedded parent hospital namely, Sahyog Hospital at a distance of less than 2 KM. Bed occupancy is reported to be higher than 50%. This is said to be the hospital in Guna which has a cathedral lab for heart procedures in Guna. The Hospital is NABH certified. In addition, the College has bed allocation for clinical training from government hospital.


In view of the above, the Committee finds that the College meets the eligibility conditions for nursing education and should be considered suitable.

2. The Committee also considered cases of the following 3 Colleges which were visited by Chairman Jst. Sh. Srivastava and Member Sh. RS Julaniya on 5th and 6th March 2025:


#	Nursing College	Findings	Grounds
1	New Era College of Nursing, Dewas	Suitable	The Committee considered the case of the College on 27 th January and had apprehensions on the truthfulness of submissions made by the College. On sudden inspection the faculty was found at site and interaction with the faculty was found it to be regular and genuine. The College has constructed a new building exclusively for nursing education having adequate sizes of rooms/halls for class rooms and laboratories, etc. Thus, the College is found suitable for nursing education.
2	Global Prashanti Nursing College, Ujjain	Suitable	The Committee considered the case of the College on 27 th January and noted that (a) documents and photos submitted support removal of building and facilities related deficiencies and (b) apprehended poor bed occupancy of its parent hospital so as to allow meaningful clinical training to students. On sudden inspection the hospital was found functional with in-patient number being more than 60. The College has removed the deficiencies noted by CBI.
3	Arogya Institute of Nursing, Ratlam	Suitable	The Committee considered the case of the College on 27 th January and noted that (a) submissions made during the hearing and

			perusal of photos support the contention of removal of infrastructure related deficiencies, and (b) interaction with the faculty during Goggle Meet video conference raised doubts on availability of full-time faculty and their academic qualifications and/or competencies. On sudden inspection the faculty was found at site and interaction with the faculty was found it to be regular and genuine. The College has removed the deficiencies noted by CBI.
